Discussions took place on work that is required to be completed including the commencement of clearing land for a vegetation bund. Lauren Stevens suggested that Walker Quarries advertise and make the Community aware of the approved clearing process prior to it starting.

Walker Quarries will also advise Lithgow Council and members of the Community Consultative Committee 2 days prior to the commencement of clearing land to the North East.

One notification was received on the 24th October 2017 where a truck exiting the quarry turned right in foggy conditions, it has been recorded in Complaints Register on the Company Website.

Actions taken as shown on the register included notifying Driver that he was in breach of Truck Driver Code of Conduct (see attached document) and was given a warning and re-inducted on next visit to site.

GENERAL BUSINESS: Notifications of future meetings will be sent via email or post for those who requested, and a phone call will also be made 4 weeks prior to the next meeting. An Invitation for new members to be considered.

Lance Gillespie raised the question as whether there have been any reports on intruders recently. Ray explained that the company has the quarry patrolled by Mitchell's Security on a regular basis and that they have not reported any suspicious activity.

TRUCK DRIVERS CODE OF CONDUCT

Purpose:

To manage the movement of Heavy Vehicles using best industry practice.

General Requirements:

DO NOT EXIT SITE IF THE FOG SIGN IS NOT FULLY VISIBLE OR ADVERSE CONDITIONS SUCH AS SNOW IS PRESENT

- Ensure you are fit to operate the truck
- Legal load limits will apply
- Complete an on-site Induction appropriate PPE to be worn at all times
- Hold a valid licence for the class of the vehicle you operate
- Operate the vehicle in a safe manner within and outside the quarry site
- Comply with the direction of authorized site personnel within the site
- Adhere to posted speed limits

- A working UHF Radio set to Channel 16 must be used for positive communication
- Road Trucks to GIVE WAY to WATERCART

Load Covering:

A wind out tarp is mandatory and all care is to be taken to ensure the truck body is free from all loose material before leaving the quarry site and after unloading

Driver Fatigue:

All heavy vehicle drivers operating out of the Walker Quarries site are to be aware of the relevant fatigue management plans applicable and operate within these limits

Declaration:

I, the undersigned hereby agree to abide by Walker Quarries Truck Drivers Code of Conduct in the transportation of quarry products from Walker Quarries to their delivery point in a safe manner.
